
Significance statement: *N*,*N*-dimethyltryptamine (DMT) is a serotonergic psychedelic with potential as a tool for probing the neurobiology of consciousness and as a therapeutic agent for psychiatric disorders. However, the neurochemical and neurophysiological effects of DMT in rat, a preferred animal model for mechanistic studies, are unclear. We demonstrate that intravenous DMT caused a dose-dependent increase in serotonin and dopamine in medial prefrontal and somatosensory cortices, and simultaneously increased gamma functional connectivity. Similar effects have been shown for other serotonergic and atypical psychedelics, suggesting a shared mechanism of drug action. Additionally, we report DMT during normal wakefulness in two spatially and functionally distinct cortical sites - prefrontal, somatosensory - at levels comparable to those of serotonin and dopamine, supporting a physiological role for endogenous DMT.







- 6. I think it should be permissible for a for-hire driver to join **multiple** fleets and platforms.






Abstract

The mathematical study of voting, social choice theory, has traditionally only been applicable to choices among a few predetermined alternatives, but not to open-ended decisions such as collectively selecting a textual statement. We introduce generative social choice, a design methodology for open-ended democratic processes that combines the rigor of social choice theory with the capability of large language models to generate text and extrapolate preferences. Our framework divides the design of AI-augmented democratic processes into two components: first, proving that the process satisfies representation guarantees when given access to oracle queries; second, empirically validating that these queries can be approximately implemented using a large language model. We apply this framework to the problem of summarizing free-form opinions into a proportionally representative slate of opinion statements; specifically, we develop a democratic process with representation guarantees and use this process to portray the opinions of participants in a survey about abortion policy. In a trial with 100 representative US residents, we find that 84 out of 100 participants feel "excellently" or "exceptionally" represented by the slate of five statements we extracted.

My MP came round once before the election, never seen him since. Brussels feels distant, but Westminster feels worse - at least Brussels didn't bail out the banks with my taxes while I took a pay cut. This referendum, it's the first time anyone's asked me anything in years.

That probably tells you all you need to know."

Conversation: What matters most to you about the UK's relationship with Europe?

User: I think we should control our own borders, make our own laws.

AI: What would that change for you personally?

User: Well, my town's changed a lot. Lot of Eastern Europeans moved in, shops are different, hear different languages.

AI: How does that affect your daily life?

User: It's... it's not them really. They work hard. It's just it happened so fast and nobody asked. Makes you feel like you don't matter.

AI: Who should have asked?

User: The government I suppose. But they don't care what we think. They bailed out the bankers, gave them bonuses while we had austerity. My daughter's a teacher, her pay's been frozen for years. They listen to the City, not to us.

AI: So if you could change one thing, what would it be?

User: Make them listen. Make them accountable. This vote, leaving the EU, maybe that'll shake things up. Maybe then they'll pay attention.

Preference 1

We remain in the European Union but renegotiate our relationship to address the concerns that surfaced. This means regaining some control over immigration policy - not ending free movement, but giving local councils the ability to manage integration when demographic change happens faster than infrastructure can support

Preference 2

We leave the European Union formally but negotiate a close partnership modeled on Norway's relationship with the EEA. This gives us the sovereignty of being outside the EU while maintaining the economic benefits of single market access for trade and business.

Preference 3

A public inquiry into the 2008 financial crisis with powers to claw back executive bonuses paid before the crash, comprehensive banking sector reforms separating retail from investment banking, and a £50 billion regional investment fund paid for by a financial transactions tax on the City of London
